Alternatively you may print and complete the form below and return it via fax, regular mail or email to [MMSI@BoatUS.com](mailto:MMSI@BoatUS.com). Expect to receive your MMSI number within 4-10 days of receipt. **The Fee for MMSI registration through this program is \$25.00.** This fee will be waived for current BoatU.S. Members. (Be sure to include your BoatU.S. Member number on the registration form.)

The BoatUS MMSI Program has been certified by both the Federal Communications Commission and the U.S. Coast Guard to assign MMSI numbers to vessels with DSC capable radios that are *not* required by law to carry a radio, and do *not* make international voyages or communications in foreign ports. If your vessel does not fit in this category, or you are unsure, contact the U.S. Federal Communications Commission at: (877) 480-3201 (select option 2), 445 12<sup>th</sup> St. SW, Washington, DC 20554, [fccinfo@fcc.gov](mailto:fccinfo@fcc.gov). **Be aware that the BoatU.S. MMSI Registrations reside in the U.S. Coast Guard MISLE search and rescue database only. FCC assigned MMSI in connection with a ship station license reside in the International ITU Search & Rescue database.**

### Important Programming Note:

Please be careful when initially entering your newly assigned MMSI number. Most radios only allow one opportunity to program the number. If there is an error, the unit will have to be returned to the manufacturer to be reset. Check your owner's manual carefully. Once programmed, the MMSI will stay with that radio. If at some point you no longer own the programmed radio, be sure to cancel the MMSI so that it can be transferred to the new owner, if any.

### INSTRUCTIONS:

1. Note required fields as indicated by an (\*). These fields must be completed in order to receive an MMSI number.
2. Refer to the Ship Classification table when completing the Ship Classification Question.
3. Upon receipt, keep a copy of your MMSI confirmation with your vessel documents.

### QUALIFICATION QUESTIONS – ADDITIONAL INFORMATION

- Where is the boat registered or documented? **Other = DO NOT SUBMIT THIS FORM TO BOATU.S.**  
You **must obtain a ship station license** and MMSI through your country of Registry. To look up your country's contact information go to: [www.itu.int/online/mms/mars/ctry\\_search.sh](http://www.itu.int/online/mms/mars/ctry_search.sh)
- Is your vessel over 64' in length? **Yes = DO NOT SUBMIT THIS FORM TO BOATU.S.**  
You are required to carry a ship station license and must obtain your MMSI through the FCC in connection with that license.
- Does the vessel have any transmitting equipment other than VHF or AIS (such as Single Sideband Radio or a boat-dedicated satellite telephone)? **Yes = DO NOT SUBMIT THIS FORM TO BOATU.S.**

Federal users must obtain MMSI assignments from their agency radio spectrum management office in accordance with Section 6.6 of the NTIA Manual. Official DHS and U.S. Coast Guard users can obtain an MMSI through Commandant (CG-652) in accordance with Commandant Instruction M2000.3D, Section 11.D. U.S. Coast Auxiliary surface vessel operators should request assignment of MMSIs using the same method as for a U.S. Non-Federal user.

**Ship Station Licensing Assistance:** FCC Gettysburg, PA 877-480-3201 opt 2, Universal Licensing System "Licensing Support Center" for questions & personal assistance. Turnaround time for online applications is approximately 24 hours. Once you receive notification of approval of your application, you can print your Station License Certificate, which is required to be posted on the bulkhead near the vessel's radio equipment.

**Form 160** (FRN) FCC reg # - free - personal ID good for life - for FCC system use only - must have/get one to do business w/ FCC

**Form 605** - Ship Station License, for boat \$220 for 10 yrs [ (\$15 refund of the regulatory fee portion for each remaining year of the term if cancelled prior to expiration) <http://transition.fcc.gov/Forms/Form605/605.pdf>

**Sched B** gets your vessel an internationally recognized & accessible MMSI - free - use same MMSI with AIS and (generally) all DSC radios onboard <http://transition.fcc.gov/Forms/Form605/605b.pdf>

**Sched E** (rrtop)(RR) - permit to use a marine radio \$70 - your personal permit, good for life (Note distinction: vessel needs LICENSE; you need PERMIT) <http://transition.fcc.gov/Forms/Form605/605e.pdf>
